This project is for the new privacy wall along Sienna Greens HOA along Inverrary Boulevard and Environ Boulevard and also for new privacy wall at the City Fire Station 57 / Garage site.

Our proposal includes sketch and legal of wall location as needed to record easement with the Sienna Greens HOA to locate the wall in their common area. No survey is anticipated in our fees for the City Garage / Fire Station site.

4. Permitting assistance or studies of off site areas surrounding the site, not noted herein.

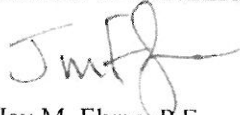
5. Additional construction observation services not considered normal and customary.
