THE CITY COMMISSION IS BEING REQUESTED TO APPROVE THE PIGGYBACKING OF THE PRICING ON THE CITY OF SUNRISE CONTRACT FOR THE PURCHASE OF POLICE UNIFORMS AND ACCESSORIES. THE CONTRACT WAS AWARDED TO IN UNISON SCHOOL APPAREL, LLC. BEGINNING JANUARY 9, 2018 AND EXTENDS TO JANUARY 8, 2020 WITH TWO, ONE-YEAR RENEWAL OPTIONS.
