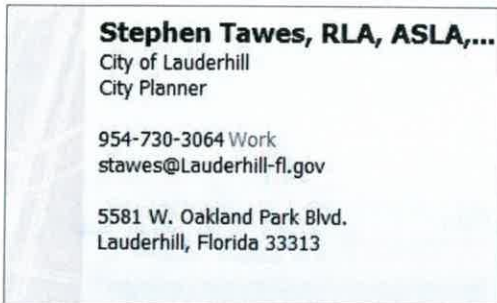

I have reviewed the revised traffic management plan for ASA. There will be one Traffic/Student Monitor stationed at NW 64 Avenue and West Commercial Blvd. This person will facilitate crossing students at that intersection. A second Traffic Student Monitor will be stationed out in front of the school to facilitate the movement of students utilizing eastbound buses to the school. Only the bus stops east of the school (south side of Commercial Blvd.) will be authorized for the students to use. The bus stop west

of the school is not authorized for student use. They will also be there to prevent student trespassing from the north side of Commercial Blvd to the south side towards the school. The School Security Officer will also be positioned outside the school and will be able to assist the Traffic Monitors as necessary. Should there be an influx of students, additional staff will be deployed to assist the Monitors and Security Officer.

As of now, I find the plan to be adequate in addressing the safety issues of students using public transportation. Once the plan is implemented, Traffic Officers can observe the effectiveness of the traffic plan.
