

## ORDINANCE NO. 170-02-113

**AN ORDINANCE OF THE CITY OF LAUDERHILL, FLORIDA AMENDING THE LAND DEVELOPMENT REGULATIONS, ARTICLE VI., PLANNING AND ZONING BOARD; SECTION 12, TERM OF OFFICE; AMENDING THE PROVISIONS TO PROVIDE THAT APPOINTMENTS SHALL BE CONCURRENT WITH EACH INDIVIDUAL CITY COMMISSIONER'S SEAT FOR STAGGERED TERMS, INSTEAD OF THE ENTIRE NEW BOARD BEING APPOINTED WITHIN 60 DAYS FOLLOWING EVERY GENERAL ELECTION; PROVIDING FOR CODIFICATION; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY MAYOR RICHARD J. KAPLAN)**

BE IT ORDAINED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

SECTION 1. Land Development Regulations Article VI, Planning and Zoning Board, Section 12., Term of Office, is hereby amended to read as follows:

### **Sec. 12. - Term of office.**

~~The term of office of each member shall begin upon his or her appointment and terminate concurrent with the expiration of the term of the City Commissioner that appointed the member. Sitting board members may continue to serve up to sixty (60) days following the expiration of their term until a new appointment is made by the appointing City Commissioner for the new term. If a City Commissioner should leave or be removed from officer for any reason prior to the natural expiration of their term, the appointed board member's term shall also expire. In addition to one (1) appointment by each individual commissioner concurrent with their seat term, the Commission as a Whole shall also appoint two (2) members who shall serve for a staggered two (2) year term. after a new appointment is made. Within sixty (60) days following each general election, the new Board shall be appointed in the manner as set forth in Section 2-2.5(a) of the Code. Members may serve more than one (1) term on the Board.~~

SECTION 2. Codification. The provisions of this Ordinance shall become and be made a part of the City of Lauderhill, Florida Land Development Regulations; sections of this Ordinance may be renumbered

or re-lettered to accomplish such intention; and the word "ordinance" may be changed to "article," "part," "section," or other appropriate word.

SECTION 3. Effective Date. This Ordinance shall take effect immediately upon its adoption.
