

**RESOLUTION NO. 17R-02-57**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL WAIVING COMPETITIVE BIDDING REQUIREMENTS; AUTHORIZING THE PIGGYBACK OF THE FLORIDA DEPARTMENT OF LAW ENFORCEMENT (FDLE) CONTRACT (#ITN 1531) FOR THE PURCHASE OF LIVESCAN EQUIPMENT AND SOFTWARE FROM BIOMETRIC4ALL IN AN AMOUNT NOT TO EXCEED \$15,000.00; PROVIDING FOR PAYMENT FROM THE APPROPRIATE BUDGET CODE NUMBER; PROVIDING TERMS AND CONDITIONS (REQUESTED BY CITY MANAGER, CHARLES FARANDA)**

WHEREAS, Section 2-144 of the Code provides that the City of Lauderhill may join in on cooperative purchasing plans without bids when the best interests of the City would be served; and

WHEREAS, the Florida Department of Law Enforcement (FDLE) has already solicited bids and awarded a contract (#ITN 15314) for the purchase of Livescan equipment and software from Biometric4all; and

WHEREAS, the City of Lauderhill wishes to award the contracts for the purchase of the equipment and software based upon the contract entered into with the FDLE; and

WHEREAS, the City Commission has determined that the award of this contract as set forth herein would serve the best interests of the City;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

Section 1. The waiver of competitive bidding is hereby approved.

Section 2. The award of the contract to purchase Livescan equipment and software in a total amount not to exceed \$15,000.00 from Biometric4all based upon the contract entered into with the Florida Department of Law Enforcement (FDLE) Contract #ITN 1531, a copy of which is attached hereto and incorporated by reference, is hereby approved.

Section 3. Providing that total payment in an amount not to exceed \$15,000.00 shall be made from the appropriate Budget Code Number.

Section 4. This Resolution shall take effect immediately upon its passage.
