#### **RESOLUTION NO. 17R-01-09**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL WAIVING COMPETITIVE BIDDING; AUTHORIZING THE PIGGY BACK OF THE SCHOOL DISTRICT OF PALM BEACH (BID ITB 15C-32B) TO MULITPLE VENDORS FOR THE PURCHASE OF PLAYGROUND EQUIPMENT, OUTDOOR FITNESS EQUIPMENT, SURFACING FITNESS TRAIL AND FABRIC SHADE STRUCTURES AS PART OF THE 2017 GO BOND IMPROVEMENTS; PROVIDING FOR PAYMENT FROM THE APPROPRIATE BUDGET CODE NUMBERS; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, CHARLES FARANDA)

WHEREAS, Section 2-144 of the Code provides that the City of Lauderhill may join in on cooperative purchasing plans without bids when the best interests of the City would be served; and

WHEREAS, the School District of Palm Beach has already solicited bids and awarded a contract (Bid ITB 15C-32B) to various vendors for the purchase of playground equipment, outdoor fitness equipment, surfacing fitness trail, and fabric shade structures which are some of the improvements slated to be done with the 2017 GO Bond dollars; and

WHEREAS, the City of Lauderhill wishes to award the contract to the various vendors based upon the bids by the School District of Palm Beach to purchase playground equipment, outdoor fitness equipment, surfacing fitness trail, and fabric shade structures on an as needed basis; and

WHEREAS, the City Commission has determined that the award of this contract as set forth herein would serve the best interests of the City;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

Section 1. The waiver of competitive bidding is hereby approved.

Section 2. The award of the contract to the various vendors for available purchase of playground equipment, outdoor fitness equipment, surfacing fitness trail, and fabric shade structures on an as needed basis pursuant to the contract entered into with the School District of Palm Beach (Bid ITB 15C-32B), a copy of which is attached hereto and incorporated by reference, is hereby approved.

Section 3. Providing that payment shall be made on an as needed basis from the appropriate Budget Code Numbers utilizing 2017 GO Bond funding.
