

## **RESOLUTION NO. 17R-03-79**

**A RESOLUTION OF THE CITY OF LAUDERHILL APPROVING THE LIST OF SOLE SOURCE OR SINGLE SOURCE PROVIDER DESIGNATION FOR USE ON AN AS NEEDED BASIS FOR REPAIR AND MAINTENANCE OF SPECIALIZED EQUIPMENT; PROVIDING FOR PAYMENT FROM THE APPROPRIATE BUDGET CODE NUMBERS ON AN AS NEEDED BASIS; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, CHARLES FARANDA).**

WHEREAS, Section 2-141 of the City of Lauderhill Code of Ordinances, designated situations where competitive bidding is not required; and

WHEREAS, Section 2-141(c) provides that non-competitive supplies such as products that are available only from a sole source, such as unique, custom, patented or franchise supplies are exempt from the competitive bidding requirements; and

WHEREAS, various vendors have submitted supporting documentation advising that they are sole source or single source providers of various supplies, services, repairs, maintenance, or parts necessary to the City;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

SECTION 1. That the competitive bidding requirements are hereby waived, as these purchases are exempt from the competitive bidding requirements pursuant to Section 2-141(c) of the City Code since the following various vendors have demonstrated that they are sole source provider (s) of supplies, services, repairs, maintenance, and/or parts necessary to the City:

1. WAM GEORGIA DIVISION: C & G IS THE AUTHORIZED FULL DISTRIBUTOR FOR THE STATE OF FLORIDA FOR ALL WAM PARTS AND SERVICE
2. ALTEC INDUSTRIES, INC: AUTHORIZED DEALERSHIP IN THE STATE OF FLORIDA FOR SALES, PARTS, AND SERVICE IN THE STATE OF FLORIDA FOR AERIAL DEVICES.
3. SUPERIOR PARK: THE EXCLUSIVE DISTRIBUTOR FOR SHADE SYSTEMS
4. MOTOLIGHT: MANUFACTURER FOR THE MOTOLIGHT MOTORCYCLE LIGHT SYSTEM

SECTION 2. That the above-referenced various vendors are hereby designated as sole source provider(s) for supplies, services, repairs, maintenance, and/or parts necessary to the City on an as needed basis.

SECTION 3. That payment shall be made from the appropriate Budget Code Numbers on an as needed basis.

SECTION 4. This Resolution shall take effect immediately upon its passage.
