A RESOLUTION OF THE CITY OF COMISSION OF THE CITY OF LAUDERHILL WAIVING COMPETITIVE BIDDING REQUIREMENTS; APPROVING THE PIGGY BACK OF THE STATE OF FLORIDA NASPO CONTRACT (46151504-NASPO-17-ACS) TO PURCHASE LAW ENFORCEMENT BODY ARMOR FROM GL DISTRIBUTORS IN AN AMOUNT NOT TO EXCEED \$40,000.00; PROVIDING FOR TERMS AND CONDITIONS; PROVIDING FOR PAYMENT FROM THE APPROPRIATE BUDGET CODE NUMBERS: PROVIDING FOR AN EFFECTIVE DATE, (REQUESTED BY CITY MANAGER, CHARLES FARANDA).

WHEREAS, Section 2-144 of the Code provides that the City of Lauderhill may join in on cooperative purchasing plans without bids when the best interests of the City would be served; and

WHEREAS, the State of Florida NASPO has already solicited bids and awarded a contract (46151504-NASPO-17ACS) to GL Distributors for the purchase of law enforcement body armor to be used by the police department; and

WHEREAS, the City of Lauderhill wishes to award the contract to GL Distributors based upon the bids by the State of Florida NASPO to purchase the body armor indicated on the attached; and

WHEREAS, the City Commission has determined that the award of this contract as set forth herein would serve the best interests of the City;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

Section 1. The waiver of competitive bidding is hereby approved.

Section 2. The award of the contract to GL Distributors for the purchase of the body armor indicated based upon the quotes received pursuant to the State of Florida NASPO Contract (46151504-NASPO-17-ACS), a copy of which is attached hereto and incorporated by reference, is hereby approved.

Section 3. Providing that payment in the total amount not to exceed \$40,000.00 shall be made on an as needed basis from the appropriate Budget Code Numbers.
