A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL WAIVING COMPETITIVE BIDDING; AUTHORIZING THE PIGGY BACK OF THE CITY OF FORT LAUDERDALE BID (NO. 863-11794), FOR THE PURCHASE, INSTALLATION AND REMOVAL OF VEHICLE GRAPHIC SERVICES FROM GRAPHIC DESIGNS INTERNATIONAL, INC. ON AN AS NEEDED BASIS IN AN AMOUNT NOT TO EXCEED \$40,000.00; PROVIDING FOR PAYMENT FROM BUDGET CODE NUMBER 001-512-4620 ON AN AS NEEDED BASIS; PROVIDING FOR AN EFFECTIVE DATE; (REQUESTED BY CITY MANAGER, CHARLES FARANDA)

WHEREAS, Section 2-144 of the Code provides that the City of Lauderhill may join in on cooperative purchasing plans without bids when the best interests of the City would be served; and

WHEREAS, the City of Fort Lauderdale has already solicited bids and awarded a contract (Bid No. 863-11794) to Graphic Designs International, Inc. for the purchase, installation and removal of vehicle graphic services from Graphic Designs International, Inc.; and

WHEREAS, the City of Lauderhill wishes to award the contract to Graphic Designs International, Inc. based upon the bids by the City of Fort Lauderdale to purchase, install and remove vehicle graphics on an as needed basis; and

WHEREAS, the City Commission has determined that the award of this contract as set forth herein would serve the best interests of the City;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

<u>Section 1</u>. The waiver of competitive bidding is hereby approved.

Section 2. The award of the contract to Graphic Designs International, Inc. for the purchase, installation and removal of vehicle graphic services in an amount not to exceed \$40,000.00 based upon the quotes received pursuant to the City of Fort Lauderdale Bid (No. 863-11794), a copy of which is attached hereto and incorporated by reference, is hereby approved.

Section 3. Providing that payment in the total amount of \$40,000.00 on an as needed basis shall be made on an as needed basis from Budget Code Number 001-512-4620.
