A RESOLUTION WAIVING COMPETITIVE BIDDING REQUIREMENTS; APPROVING THE AWARD OF CONTRACT TO SUPERIOR PARK SYSTEMS, INC. BASED UPON THE BIDS SOLICITED BY THE SCHOOL DISTRICT OF PALM BEACH COUNTY, FLORIDA (15C-32B); APPROVING THE PIGGYBACK PURCHASE IN THE AMOUNT OF \$64,021.25 FOR ARTIFICIAL PLAYGROUND TURF FOR USE AT RUTH ROTHKOPH PARK; PROVIDING FOR PAYMENT UTILIZING GENERAL OBLIGATION (GO) BOND FUNDS FROM BUDGET CODE NUMBER 307-334-06923; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, CHARLES FARANDA)

WHEREAS, Section 2-144 of the Code provides that the City of Lauderhill may join in on cooperative purchasing plans without bids when the best interests of the City would be served; and

WHEREAS, the School District of Palm Beach County has already solicited bids (15C-32B) and awarded a contract to Superior Park Systems, Inc. for the purchase of artificial playground turf; and

WHEREAS, the City of Lauderhill wishes to award the contract to Superior Park Systems, Inc. based upon the bids by the School District of Palm Beach County to purchase artificial playground turf for use at Ruth Rothkoph Park as indicated on the attached; and

WHEREAS, the City Commission has determined that the award of this contract as set forth herein would serve the best interests of the City;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

Section 1. The waiver of competitive bidding is hereby approved.

<u>Section 2</u>. The award of the contract to Superior Park Systems, Inc. for the purchase of artificial playground turf for use at Ruth Rothkoph Park, based upon the bids solicited by the School District of Palm Beach County (15C-32B), a copy of which is attached hereto and incorporated by reference, is hereby approved.

<u>Section 3</u>. Providing that payment in the amount of \$64,021.25 shall be made from Budget Code Number 307-334-06923 utilizing General Obligation (GO) Bond funds.

<u>Section 4.</u> This Resolution shall take effect immediately upon its passage.
