

RESOLUTION NO. 17R-03-103

A RESOLUTION APPROVING THE AWARD OF THE CONTRACT TO PORT CONSOLIDATED, INC. TO ALLOW FOR THE PURCHASE OF UNLEADED GASOLINE AND DIESEL FUEL, ON AN AS NEEDED BASIS, BASED UPON THE BIDS SOLICITED BY THE CITY OF POMPANO BEACH AS "LEAD AGENCY" FOR THE SOUTHEAST FLORIDA GOVERNMENTAL PURCHASING CO-OPERATIVE GROUP; PROVIDING FOR PAYMENT FROM BUDGET CODE NUMBERS 001-138-05240 AND 001-138-05241; PROVIDING TERMS AND CONDITIONS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 2-144 of the Code provides that the City of Lauderhill may join in on cooperative purchasing plans without bids when the best interests of the City would be served; and

WHEREAS, the City of Pompano Beach has already solicited bids (RFP E-13-17) and awarded a contract to Port Consolidated, Inc.; and

WHEREAS, the City of Lauderhill wishes to award a contract to Port Consolidated, Inc. based upon the bids solicited by the City of Pompano Beach for the purchase of unleaded gasoline and diesel fuel on an as needed basis, as indicated on the attached; and

WHEREAS, the City Commission has determined that the award of this contract as set forth herein would serve the best interests of the City;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

Section 1. The waiver of competitive bidding is hereby approved.

Section 2. The award of the contract to Port Consolidated, Inc. for the purchase of unleaded gasoline and diesel fuel on an as needed basis, based upon the bids solicited by the City of Pompano Beach as "Lead Agency" for the Southeast Florida Governmental Purchasing Co-operative Group (RFP E-13-17), a copy of which is attached hereto and incorporated by reference, is hereby approved.

Section 3. Providing that payment shall be made from Budget Code Numbers 001-138-05240 and 001-138-05241 on an as needed basis.

Section 4. This Resolution shall take effect immediately upon its passage.
