A RESOLUTION APPROVING THE AWARD OF THE CONTRACT TO PORT CONSOLIDATED, INC. TO ALLOW FOR THE PURCHASE OF UNLEADED GASOLINE AND DIESEL FUEL, ON AN AS NEEDED BASIS, BASED UPON THE BIDS SOLICITED BY THE CITY OF POMPANO BEACH AS "LEAD AGENCY" FOR THE SOUTHEAST FLORIDA GOVERNMENTAL PURCHASING CO-OPERATIVE GROUP; PROVIDING FOR PAYMENT FROM BUDGET CODE NUMBERS 001-138-05240 AND 001-138-05241; PROVIDING TERMS AND CONDITIONS; PROVIDING FOR AN EFFECTIVE DATE

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

Section 1. The waiver of competitive bidding is hereby approved.

<u>Section 2</u>. The award of the contract to Port Consolidated, Inc. for the purchase of unleaded gasoline and diesel fuel on an as needed basis, based upon the bids solicited by the City of Pompano Beach as "Lead Agency" for the Southeast Florida Governmental Purchasing Co-operative Group (RFP E-13-17), a copy of which is attached hereto and incorporated by reference, is hereby approved.

<u>Section 3</u>. Providing that payment shall be made from Budget Code Numbers 001-138-05240 and 001-138-05241 on an as needed basis.
