**A RESOLUTION OF THE CITY OF LAUDERHILL APPROVING THE PROPOSAL OF SYNALOVSKI ROMANIK SAYE IN THE AMOUNT OF \$169,850.00 FOR PRE-DESIGN, SCHEMATIC DESIGN, AND THE DEVELOPMENT OF A DESIGN CRITERIA PACKAGE TO USE IN SOLICITING DESIGN-BUILD TEAMS FOR UPCOMING GENERAL OBLIGATION (GO) BOND IMPROVEMENTS AT ST. NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

SECTION 1. The proposal from Synalovski Romanik Saye in the amount of \$169,850.00 for pre-design, schematic design and development of a design criteria package to use in soliciting firms for upcoming General Obligation (GO) bond improvements at St. George Park, a copy of which is attached hereto and incorporated herein, is hereby approved.
