A RESOLUTION OF THE CITY OF LAUDERHILL APPROVING THE PROPOSAL FROM BERMELLO AJAMIL & PARTNERS, INC. IN THE AMOUNT OF \$61,080.00 FOR PRE-DESIGN, SCHEMATIC DESIGN, AND THE DEVELOPMENT OF A DESIGN CRITERIA PACKAGE TO USE IN SOLICITING DESIGN-BUILD TEAMS FOR UPCOMING GENERAL OBLIGATION (GO) BOND IMPROVEMENTS AT THE LAUDERHILL GOLF COURSE; PROVIDING FOR PAYMENT FROM BUDGET CODE NUMBER 307-335-06212 UTILIZING GENERAL OBLIGATION (GO) BOND FUNDS; PROVIDING TERMS AND CONDITIONS; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, CHARLES FARANDA)
