A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL WAIVING COMPETITIVE BIDDING REQUIREMENTS AND APPROVING THE PIGGYBACK OF THE CITY OF FORT LAUDERDALE FOR BUILDING DIVISION PLAN REVIEW AND INSPECTION SERVICES TO BE PROVIDED BY C.A.P. GOVERNMENT, INC., ON AN AS NEEDED BASIS, EFFECTIVE FOR THE BALANCE OF THE TERM THROUGH JUNE 16, 2019; PROVIDING THAT THERE IS ONE (1) ADDITIONAL TWO-YEAR OPTION TO RENEW REMAINING; PROVIDING FOR PAYMENT AS NECESSARY FROM BUDGET CODE NUMBER 001-212-03110; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, CHARLES FARANDA)

WHEREAS, Section 2-144 of the Code provides that the City of Lauderhill may join in on cooperative purchasing plans without bids when the best interests of the City would be served; and

WHEREAS, the City of Fort Lauderdale has already solicited bids and awarded a contract to C.A.P. Government, Inc. to provide building division plan review and inspections services on an as needed basis; and

WHEREAS, the City of Lauderhill wishes to award the contract to C.A.P. Government, Inc., based upon the bids received by the City of Fort Lauderdale, for building division plan review and inspection services; and

WHEREAS, the City Commission has determined that the award of this contract as set forth herein would serve the best interests of the City;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

<u>Section 1</u>. The waiver of competitive bidding is hereby approved.

<u>Section 2</u>. The award of the contract to C.A.P. Government, Inc. to provide building division plan review and inspections services on an as needed basis, based upon the bids received pursuant to the City of Fort Lauderdale Contract, a copy of which is attached hereto and incorporated by reference, is hereby approved.

<u>Section 3</u>. Providing that payment shall be made on an as needed basis from Budget Code Number 001-212-03110.

<u>Section 4.</u> This Resolution shall take effect immediately upon its passage.
