A RESOLUTION OF THE LAUDERHILL COMMUNITY REDEVELOPMENT AGENCY (CRA) APPROVING AMENDMENT NO. 1 TO THE SUBRECIPIENT AGREEMENT BETWEEN THE CITY OF LAUDERHILL AND THE LAUDERHILL COMMUNITY REDEVELOPMENT AGENCY (CRA) FOR ECONOMIC ACTIVITIES REGARDING REHABILITATION OF COMMERCIAL/INDUSTRIAL PROPERTY INCLUDING, BUT NOT LIMITED TO, FACADE IMPROVEMENTS AND SIDEWALK REPAIRS IN EASTERN LAUDERHILL'S CRA DESIGNATED AREA; AUTHORIZING THE EXECUTIVE DIRECTOR TO EXECUTE ANY NECESSARY DOCUMENTS; PROVIDING TERMS AND CONDITIONS; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY EXECUTIVE DIRECTOR, SEAN HENDERSON).

BE IT RESOLVED BY THE LAUDERHILL COMMUNITY REDEVELOPMENT AGENCY (CRA) OF THE CITY OF LAUDERHILL, FLORIDA:

Section 1. The Amendment No. 1 to the Subrecipient Agreement between the City of Lauderhill and the Lauderhill Community Redevelopment Agency (CRA) for Economic Activities regarding rehabilitation of commercial/industrial property including, but not limited to, façade improvements and sidewalk repairs in Eastern Lauderhill's CRA designated area, a copy of which is attached hereto and incorporated herein, is hereby approved.

Section 2. Finding that funding such improvements would be a beneficial use of public dollars in support of economic development opportunities on the site and would have a positive impact on the community

Section 3. That the Executive Director is hereby designated as the authorized representative on behalf of the CRA to execute the Subrecipient Agreement and file any application(s) or documents to fulfill the terms of this Resolution, to provide assurances, and to make representations on behalf of the CRA.

Section 4. This Resolution shall take effect immediately upon its adoption and passage.
