## RESOLUTION NO. 19R-02-37

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL DESIGNATING STRYKER AS A SOLE SOURCE MANUFACTURER OF THE STRYKER EMS POWER-LOAD COT FASTENER (MODEL 6390) BATTERY-OPERATED STRETCHERS FOR USE BY THE FIRE DEPARTMENT; APPROVING THE PURCHASE OF SIX (6) NEW STRYKER POWER PRO COT BATTERY-OPERATED STRETCHERS IN A TOTAL AMOUNT NOT TO EXCEED \$97,495.25 TO BE PAID OVER A FIVE (5) YEAR TERM FROM THE APPROPRIATE BUDGET CODE NUMBER; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, CHARLES FARANDA)

WHEREAS, Section 2-141 of the City of Lauderhill Code of Ordinances, designated situations where competitive bidding is not required; and

WHEREAS, Section 2-141(c) provides that non-competitive supplies such as products that are available only from a sole source, such as unique, custom, patented or franchise supplies or services are exempt from the competitive bidding requirements; and

WHEREAS, Stryker Medical has represented that they are the sole source manufacturer of the Stryker EMS Power-LOAD Cot Fastener (Model 6390) battery-operated stretcher;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

<u>SECTION 1</u>. That the competitive bidding requirements are hereby waived, as this purchase is exempt from the competitive bidding requirements pursuant to Section 2-141(c) of the City Code since Stryker is hereby designated as a sole source manufacturer of the EMS Power-LOAD Cot Fastener (Model 6390) battery-operated stretcher.

<u>SECTION 2</u>. That payment in the total amount not to exceed \$97,495.25 shall be may be made over a five (5) year period from the appropriate Budget Code Number.

<u>SECTION 3</u>. This Resolution shall take effect immediately upon its passage.
