

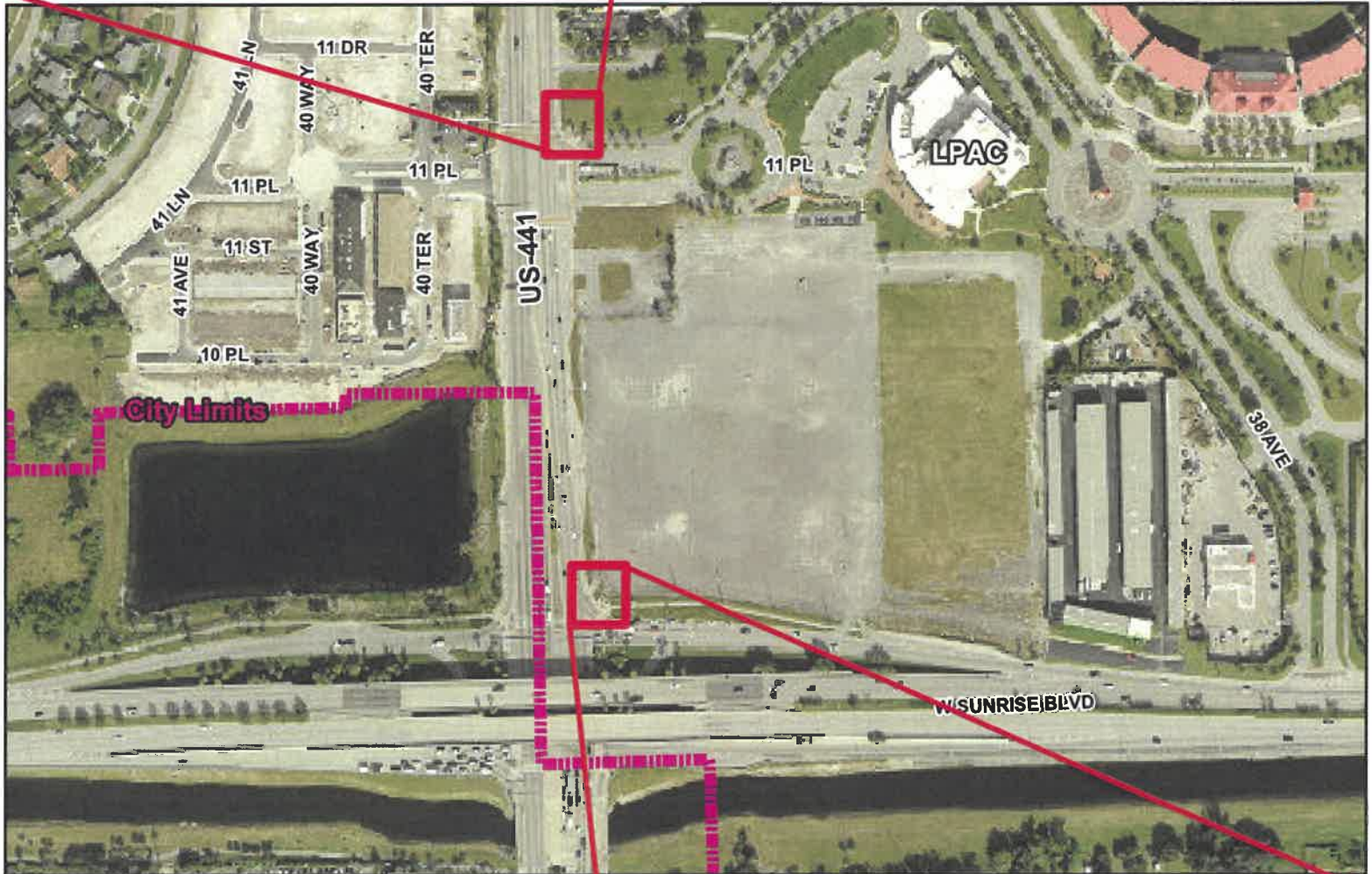

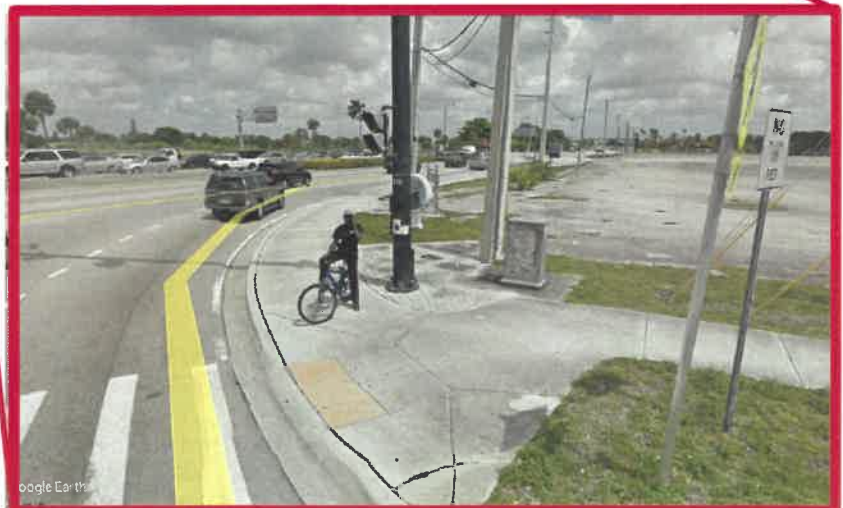
Concrete base 48" x 37" x 7 1/2"

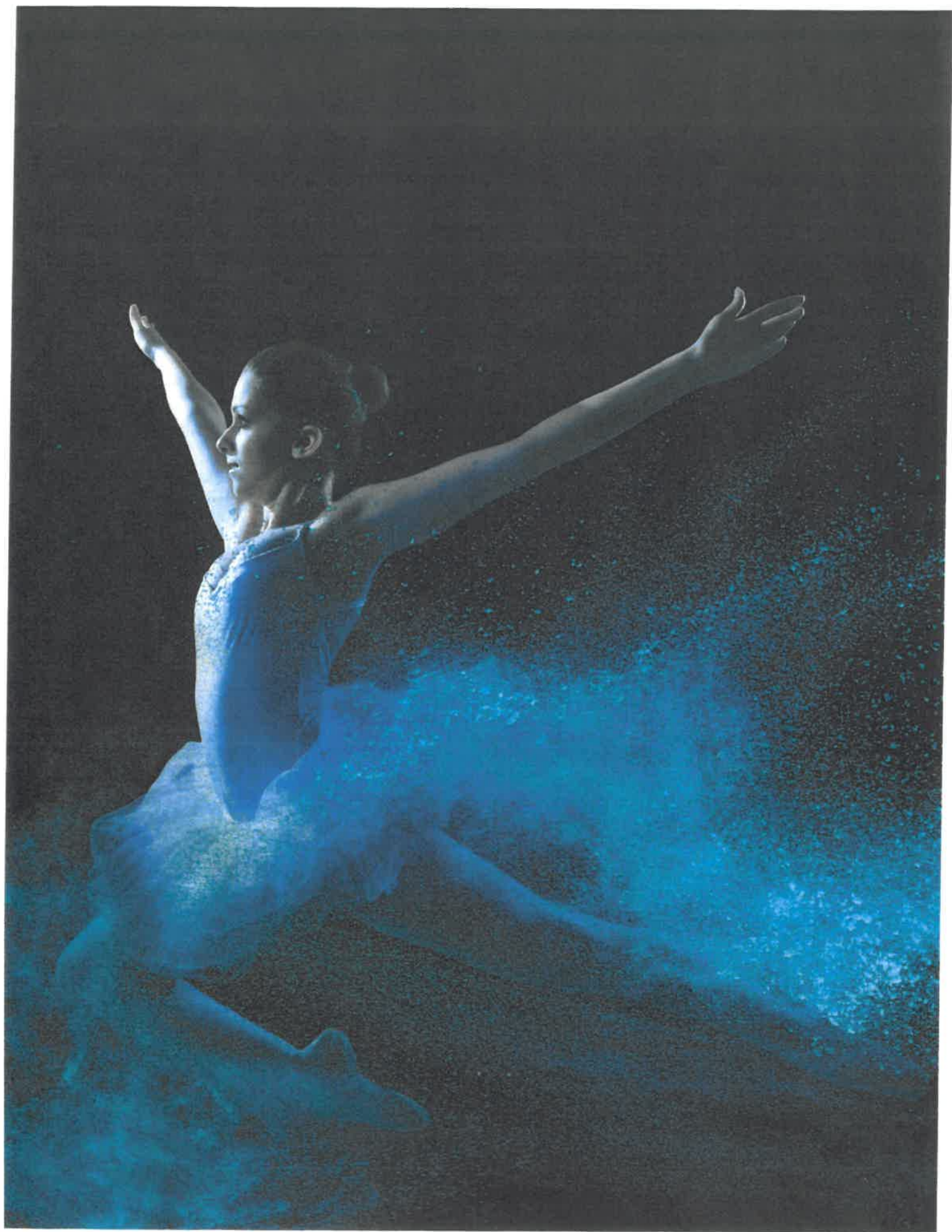
