## **Request Action:**

A RESOLUTION IS REQUIRED FROM THE CITY COMMISSION TO APPROVE THE FIRST AMENDMENT TO THE CURRENT CDBG SUBRECIPIENT AGREEMENT (SA) BETWEEN THE CITY OF LAUDERHILL AND THE WINDERMERE CONDOMINIUM ASSOCIATION (WCA) FOR DIRECT LOAN REHABILITATION SERVICES PROJECT 1.

#### Need:

ACTION IS REQUIRED TO OBTAIN COMMISSION APPROVAL TO AMEND THE CURRENT CDBG SUBRECIPIENT AGREEMENT BETWEEN THE CITY AND WCA FOR PROJECT 1.

# **Summary Explanation/ Background:**

THE CITY ENTERED INTO A SUBRECIPIENT AGREEMENT WITH WCA FOR CDBG FUNDING TO PERFORM ELIGIBLE HEALTH AND SAFETY REHABILITATION SERVICES TO THE WINDERMERE COMMUNITY.

SERVICES RENDERED INCLUDE, BUT ARE NOT LIMITED; TO WINDOW REPLACEMENTS, BALCONY REPAIRS, METER ROOM IMPROVEMENTS, AND OTHER HEALTH AND SAFETY RELATED SERVICES AS DEEMED NECESSARY.

STAFF IS RECOMMENDING THE APPROVAL OF THE FIRST AMENDMENT TO INCORPORATE REQUIRED SCOPE CHANGES DUE TO INCREASES IN CONSTRUCTION COSTS, EXTEND THE TERM OF THE AGREEMENT, AND INCLUDE TECHNICAL REVISIONS OBLIGATORY FOR PROJECT CLOSEOUT.
