A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL AUTHORIZING A CHANGE ORDER TO THE CONTINENTIAL CONSTRUCTION USA, LLC. CONTRACT IN AN AMOUNT NOT TO EXCEED \$250,000.00 TO AUTHORIZE PAYMENT FOR ADDITIONAL WORK THAT WAS RENDERED NECESSARY FOR THE N.W. 21<sup>ST</sup> STREET WATER & SEWER IMPROVEMENT PHASE I DUE TO UNFORESEEN CONDITIONS OF THE EXISTING INFRASTRUCTURE THAT WAS DISCOVERED DURING CONSTRUCTION; PROVIDING FOR PAYMENT FROM THE APPROPRIATE BUDGET CODE NUMBER(S); PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, CHARLES FARANDA)

WHEREAS, the N.W. 21<sup>st</sup> Street Water & Sewer Phase I Improvements project was an extensive and highly invasive undertaking; and

WHEREAS, due to the nature of underground work, this project ran into a variety of conflicts and issues that were discovered during construction which included unforeseen underground conditions of existing infrastructure, or lack of detailed information of the plans provided needed to be resolved in order that the project could move forward; and

WHEREAS, this additional work was necessary in order to complete the job and shall not exceed \$250,000.00;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

<u>SECTION 1</u>. The Change Order to the Continental Construction USA, LLC. Contract, Inc. in an amount not to exceed \$250,000.00 for additional work that was rendered necessary for the N.W. 21<sup>st</sup> Street Water & Sewer Improvement Phase I due to unforeseen conditions of the existing infrastructure that was discovered during construction, a copy of which is attached hereto and incorporated herein, is hereby approved.

<u>SECTION 2</u>. Payment in an amount not to exceed \$250,000.00 shall be made from the appropriate Budget Code Number(s).
