

ORDINANCE NO. 200-04-112

AN ORDINANCE APPROVING THE SIX MONTH BUDGET REVIEW OF REVENUE AND EXPENDITURE AMENDMENTS FOR FISCAL YEAR 2020 IN THE TOTAL ADJUSTMENT AMOUNT OF \$1,132,626.00; APPROVING AN INTERDEPARTMENT BUDGET ADJUSTMENT IN THE AMOUNT OF \$515,534.00, A CAPITAL BUDGET ADJUSTMENT IN THE AMOUNT OF \$7,885.00 AND A SUPPLEMENTAL APPROPRIATION IN THE AMOUNT OF \$609,207.00; REFLECTING APPROPRIATE ADJUSTMENTS TO VARIOUS REVENUE AND EXPENDITURE ACCOUNTS; PROVIDING VARIOUS BUDGET CODE NUMBERS; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY INTERIM CITY MANAGER, DESORAE GILES-SMITH)

BE IT ORDAINED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

Section 1. The budget adjustment of interdepartment transfers in the total amount of \$515,534.00, a copy of which is attached hereto and incorporated herein, is hereby approved.

Section 2. The budget adjustment of capital transfers in the total amount of \$7,885.00, a copy of which is attached hereto and incorporated herein, is hereby approved.

Section 3. The supplemental appropriation of additional revenues and expenditures in the total amount of \$609,207.00 to the Fiscal Year 2020 budget to transfer funds among various budgeted line items to project expenditures for the remainder of Fiscal Year 2020, a copy of which is attached hereto and incorporated by reference, is hereby approved.

Section 4. The total adjustments to various revenue and expenditure accounts for the six month budget review in the total amount of \$1,132,626.00 is hereby approved.

Section 5. All ordinances or parts of ordinances, all resolutions or parts of resolutions in conflict herein be and the same are hereby repealed as to the extent of such conflict.

Section 6. This Ordinance shall take effect immediately upon its passage.
