The supplemental appropriation of additional revenues and expenditures in the total amount of \$609,207.00 to the Fiscal Year 2020 budget to transfer funds among various budgeted line items to project expenditures for the remainder of Fiscal Year 2020, a copy of which is attached hereto and incorporated by reference, is hereby approved.

<u>Section 4.</u> The total adjustments to various revenue and expenditure accounts for the six month budget review in the total amount of \$1,132,626.00 is hereby approved.

<u>Section 5.</u> All ordinances or parts of ordinances, all resolutions or parts of resolutions in conflict herein be and the same are hereby repealed as to the extent of such conflict.
