

## **RESOLUTION 20R-05-83**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL APPROVING THE RANKING OF QUALIFIED FIRMS PURSUANT TO RFP #2020-014 FOR DESIGN-BUILD SERVICES FOR CITY HALL ANNEX AS RECOMMENDED BY THE EVALUATION COMMITTEE IN AN AMOUNT NOT TO EXCEED \$3,867,142.00; PROVIDING FOR PAYMENT FROM BUDGET CODE NUMBER 307-338-06318; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY INTERIM CITY MANAGER, DESORAE GILES-SMITH)**

BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

SECTION 1. The following are ranked to be negotiated with for Design-Build Services for City Hall Annex pursuant to RFP #2020-014 as recommended by the Evaluation Committee:

1. AHRENS GENERAL CONSTRUCTION
2. MBR CONSTRUCTION
3. WEST CONSTRUCTION
4. WALKER DESIGN

SECTION 2. The City Commission hereby authorizes the Interim City Manager, or any designee thereof, to negotiate an agreement with the first ranked selected firm to provide design-build construction services for City Hall Annex pursuant to RFP #2020-014. If an agreement cannot be reached with the first selected firm, then the Interim City Manager, or her designee, shall attempt to negotiate an agreement with the next highest ranked firm, or go out to re-bid if no other firms are ranked, until all services are under contract.

SECTION 3. Approving payment in an amount not to exceed \$3,867,142.00 from Budget Code Number 307-338-06318.

SECTION 4. This Resolution shall take effect immediately upon its passage.
