Request Action:

A RESOLUTION OF THE CITY COMMISSION IS REQUIRED TO AUTHORIZE THE PUBLIC WORKS
DEPARTMENT TO SPEND AN ADDITIONAL \$ 479,010.00 WITH CORELAND CONSTRUCTION AS IT
PERTAINS TO RECONSTRUCTING CONCRETE SIDEWALKS, CONCRETE PADS, CURBS, ASPHALT AND
SPEED HUMPS AT VARIOUS LOCATIONS CITYWIDE.

Need:

A RESOLUTION IS NEEDED TO AUTHORIZE ADDITIONAL FUNDING FOR IMMEDIATE SIDEWALK
REPAIRS CITYWIDE.

Summary Explanation/ Background:

OVER THE PAST FIVE MONTHS, PUBLIC WORKS STAFF HAS RECEIVED AN INCREASE IN THE
NUMBER OF TRIP AND FALL CLAIMS CITYWIDE. AS SUCH, IT HAS BEEN DETERMINED THAT THERE
ARE EXTENSIVE SIDEWALK AREAS WHICH REQUIRE URGENT REPAIR AND THIS WILL RESULT IN AN
INCREASE TO THE CONTRACTED AMOUNT. ACCORDINGLY, IT IS IMPERATIVE THAT THE
DEPARTMENT PROCEEDED WITH REPAIRS IMMEDIATELY IN ORDER TO REDUCE THE LIABILITY TO
THE CITY OF LAUDERHILL. THIS RESOLUTION WILL PROVIDE THE ADDITIONAL FUNDING FOR THE
PUBLIC WORKS DEPARTMENT TO PROCEED IN HAVING CORELAND CONSTRUCTION COMPLETE
THE REPAIRS EXPEDITIOUSLY.
