### Summary Explanation/ Background:

STAFF RECOMMENDS APPROVAL OF THE BERMELLO AJAMIL & PARTNERS, INC. PROPOSAL OF THE SCOPE OF WORK TO PROVIDE IMPROVEMENTS TO HERBERT SADKIN COMMUNITY CENTER. THE PROPOSED PROJECT ELEMENTS INCLUDE REPLACEMENT OF THE FOLLOWING: EXISTING

BLEACHERS IN SECOND FLOOR GYM, MOTOR AND CABLING OF (6) SIX BASKETBALL COURTS, SCOREBOARDS, PADDING ON WALLS, FLOORING IN NAUTILUS/WEIGHT ROOM, AND NEW EXTERIOR CANOPY AT THE COURTYARD. AS SUCH, THE FIRM'S PROPOSAL WILL INCLUDE PROFESSIONAL SERVICES FOR THE DESIGN, PREPARATION OF CONSTRUCTION DOCUMENTS, SPECIFICATIONS, BIDDING ASSISTANCE SERVICES, AND DRC APPROVAL FOR CITY USE AS ITS CRITERIA IN SOLICITING FOR QUALIFIED CONTRACTORS TO BID ON THE UPCOMING PARK IMPROVEMENTS.
