ACTION IS NEEDED FOR THE ACCEPTANCE OF THE PROPOSAL FROM SUPERIOR PARK SYSTEMS, INC. REGARDING OBLIGATORY ENHANCEMENTS AS PART OF THE GO BOND IMPROVEMENTS.

Summary Explanation/ Background:

APPROVAL TO PIGGYBACK ON THE SCHOOL DISTRICT OF PALM BEACH CONTRACT NO. 15C-32B WAS ASSUMED BY RESOLUTION NO. 17R-01-09. THIS PROPOSAL WILL BE USED TO AID IN THE PURCHASE OF PLAYGROUND EQUIPMENT, SURFACING AND SHADE STRUCTURES FROM APPROVED VENDORS. STAFF IS RECOMMENDING CONSENT OF THE SUPERIOR PARK SYSTEMS,

INC. PROPOSAL OF THE SCOPE OF WORK TO PROVIDE IMPROVEMENTS TO JACKIE GLEASON PARK. THE PROPOSED PROJECT ELEMENTS INCLUDE ONE (1) CUSTOM MEGA SPAN SHADE SYSTEM WITH "TURN-N-SLIDE" EASY STORM REMOVAL OF SHADE COVER CANOPY, PROFESSIONAL ENGINEERED-SEALED DRAWINGS, CALCULATIONS & PERMITTING, AND INSTALLATION. THE NEW SHADE WILL CONTINUE THE RENOVATION OF THE PARK.
