# Need:

ACTION IS NEEDED FOR THE ACCEPTANCE OF THE PROPOSAL FROM SUPERIOR PARK SYSTEMS, INC. REGARDING OBLIGATORY ENHANCEMENTS AS PART OF THE GO BOND IMPROVEMENTS.

# Summary Explanation/ Background:

APPROVAL TO PIGGYBACK ON THE SCHOOL DISTRICT OF PALM BEACH CONTRACT NO. 15C-32B WAS ASSUMED BY RESOLUTION NO. 17R-01-09. THIS PROPOSAL WILL BE USED TO AID IN THE PURCHASE OF PLAYGROUND EQUIPMENT, SURFACING AND SHADE STRUCTURES FROM APPROVED VENDORS. STAFF IS RECOMMENDING CONSENT OF THE SUPERIOR PARK SYSTEMS, INC. PROPOSAL OF THE SCOPE OF WORK TO PROVIDE IMPROVEMENTS TO RUTH ROTHKOPH

PARK. THE PROPOSED PROJECT ELEMENTS INCLUDE 2,996 SQ. FT. OF FOREVER ULTRA ANTI ELECTRO-STATIC AND ANTI MICROBIAL ADA COMPLIANT ARTIFICIAL PLAYGROUND GRASS TURF INSTALLED INCLUDING ALL SITE PREP DEMOLITION AND REMOVAL OF ALL EXISTING MULCH AND BARRIER, DIRECT SPIKED BOARDERS DISPOSE OF ALL OFFSITE 215 LF OF CUSTOM CONCRETE CURBING INSTALLED FOR PLAYGROUND PERIMETER AND ADA COMPLIANT CONCRETE PATH TO THE PLAYGROUND INCLUDING ALL SITE PREPARATION. THE NEW TURF WILL CONTINUE THE RENOVATION OF THE PARK.
