Request Action:

Adopt a Resolution approving the donation of \$18,772.00 to the Aging and Disability Resource Center of Broward County (ADRC).

Funds matched by the City of Lauderhill to be used to continue serving Lauderhill seniors 60 years and over, and their need to live a decent retirement life with merited dignity.

The Areawide Council on Aging (ADRC) is a nonprofit 501(C) (3) corporation, is a Federal and State Mandated Local Match program where they have developed a Fair Share Methodology to secure required matched funds from local municipalities and from Broward County. The City of Lauderhill Commission approved \$18,772.00 from fiscal year 2017.
