A RESOLUTION IS REQUESTED FROM THE CITY COMMISSION TO ACCEPT THE GO BOND PROPOSAL (CCNA) FROM COMMISSION-APPROVED CONSULTANT SYNALOVSKI ROMANIK SAYE IN THE AMOUNT OF \$82,450.00 FOR PROFESSIONAL DESIGN CRITERIA FOR VETERAN'S PARK LOCATED AT 7600 NW 50 STREET, LAUDERHILL, FL.

### Need:

ACCEPTANCE OF THE PROPOSAL FROM SYNALOVSKI ROMANIK SAYE REGARDING PROFESSIONAL DESIGN CRITERIA FOR VETERAN'S PARK.

### Summary Explanation/ Background:

STAFF RECOMMENDS APPROVAL OF THE SYNALOVSKI ROMANIK SAYE PROPOSAL TO PROVIDE DESIGN CRITERIA DRAWINGS FOR A DESIGN BUILD PROJECT TO PROVIDE IMPROVEMENTS TO VETERAN'S PARK. THE PROPOSED PROJECT ELEMENTS INCLUDE RENOVATING BUILDING, INCLUDING EXTERIOR FAÇADE IMPROVEMENTS AND ADDING APPROXIMATELY 2,080 SF TO THE BUILDING INSIDE THE EXISTING COURTYARD, PROVIDE PUBLIC ADA RESTROOMS FOR PARK USE AFTER HOURS AND WEEKENDS NEW BLEACHERS AT SOCCER AND BASEBALL FIELD, NEW DUG

OUTS AND BACKSTOP FENCING AT THE BASEBALL FIELD, POOL DECK REPLACEMENT/REFINISH, ELIMINATE WADING POOL AND REPLACE WITH NEW WATER PLAY AREA, ADDRESS HEATER AND FILTER MAINTENANCE ISSUES FOR THE EXISTING COMPETITION POOL AND IDENTIFY LOCATION FOR ALTERNATE POOL SIDE SHADE STRUCTURES. EXISTING PARKING, DRIVEWAYS AND FIELDS ARE TO REMAIN AS IS. AS SUCH, THE FIRM'S PROPOSAL WILL INCLUDE PREDESIGN, SCHEMATIC DESIGN, AND DESIGN DEVELOPMENT FOR CITY USE AS A DESIGN CRITERIA PACKAGE IN SOLICITING FOR DESIGN-BUILD TEAMS TO BID ON THE UPCOMING PARK IMPROVEMENTS.
