Request Action:

A RESOLUTION IS REQUESTED FROM THE CITY COMMISSION TO PIGGYBACK THE CITY OF POMPANO BEACH'S CONTRACT TO PURCHASE UNLEADED GASOLINE & DIESEL FUEL. THE CONTRACT WAS AWARDED TO PORT CONSOLIDATED, INC.

Need:

THE CITY HAS AN ONGOING NEED FOR UNLEADED GASOLINE AND DIESEL FOR CITY VEHICLES AND GENERATORS FOR VARIOUS DEPARTMENTS. THE CURRENT AGREEMENT IS DUE FOR EXPIRATION ON MARCH 31, 2017, FOR WHICH MACMILLAN OIL COMPANY OF FLORIDA, INC. WILL NO LONGER SUPPLY GASOLINE AND DIESEL TO THE CITY AT THE CO-OPERATIVE RATES.

Summary Explanation/ Background:

THE CITY OF CORAL SPRINGS OPTED OUT OF BEING THE LEAD AGENCY ON THE EXISTING CONTRACT DUE TO EXPIRE MARCH 31, 2017. WITH THIS, THE CITY OF POMPANO BEACH IS NOW THE ACTING LEAD AGENCY FOR THE SOUTHEAST FLORIDA GOVERNMENTAL PURCHASING COOPERATIVE GROUP. THIS CONTRACT WILL ALLOW THE CITY TO RECEIVE CO-OPERATIVE PRICING BENEFICIAL TO THE CITY. CITY OF POMPANO BEACH HAS SOLICITED PROPOSALS FOR

THE NECESSARY COMMODITY, IN WHICH THE CITY IS A PARTICIPATING MEMBER.
