### Summary Explanation/ Background:

THE CITY OF LAUDERHILL SOLICITED PROPOSALS FROM INTERESTED PARTIES FOR

SUPPLY AND INSTALLATION/ CONSTRUCTION OF CONCRETE SIDEWALKS, PADS, CURBS, SPEED HUMPS AND MINOR ASPHALT INSTALLATION AND REPAIR SERVICES. FIVE FIRMS RESPONDED TO THE SOLICITATION AND THE EVALUATION COMMITTEE RANKED SUBMITTALS AND RECOMMENDED AS FOLLOWS:

1. CONCRETE WORKS & PAVING, INC.
2. SUN UP ENTERPRISES
3. FLORIDA BLACKTOP INC.
4. M&M ASPHALT MAINTENANCE INC. d/b/a ALL COUNTY PAVING
5. ARZ BUILDERS, INC.
