## **RESOLUTION NO. 24R-05-83**

A RESOLUTION APPROVING THE EXPENDITURE OF FUNDS FROM THE ADDITIONAL AMOUNT NOT TO EXCEED \$25,000.00 OF STATE LOCAL LAW ENFORCEMENT TRUST FUNDS (LETF) TO COVER THE INCREASE IN COST TO PURCHASE EUIPMENT TO OUTFIT MEMBERS WHO ARE ASSIGNED TO THE COUNTYWIDE QUICK RESPONSE FORCE FOR USE BY THE CITY OF LAUDERHILL POLICE DEPARTMENT; PROVIDING FOR PAYMENT FROM BUDGET CODE NUMBER 120-683-9935; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, DESORAE GILES-SMITH)

WHEREAS, THE City previously budgeted \$50,000.00 for the Police Department to outfit members whom are assigned to the Countywide Quick Response Force which is in the current year's capital budget; and

WHEREAS, since the equipment has to be personally fitted to each member, it was not ordered under the members actually completed the necessary training; and

WHEREAS, the equipment costs have increased and an additional \$25,000.00 in funding is need to outfit the ten (10) officers who have been trained for the Force; and

WHEREAS, this expenditure is deemed an appropriate expenditure for the use of Law Enforcement Trust Funds;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

Section 1. The expenditure of funds in the amount of \$25,000.00 from the State Local Law Enforcement Trust Fund (LETF) to cover the increase in cost to purchase the equipment necessary to outfit the trained members of the Countywide Quick Response Force for use by the City of Lauderhill Police Department, which is deemed an appropriate expenditure in accordance with law, is hereby approved.

SECTION 2. Providing that the expenditure in the amount of \$25,000.00 shall be paid from Budget Code Number 120-683-9935 and the appropriation of those funds to the necessary individual revenue and expenditure accounts is hereby approved.

SECTION 3. This Resolution shall take effect immediately upon its passage and adoption.
