A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, WAIVING COMPETITIVE BIDDING REQUIREMENTS AND AUTHORIZING THE CITY TO ENTER INTO AN AGREEMENT WITH SHYFT GROUP UPFIT SERVICES, INC., D/B/A STROBES-R-US FOR THE PURCHASE OF EMERGENCY EQUIPMENT FOR SIX POLICE VEHICLES BASED ON A PIGGYBACK FROM THE SHERIFF OF BROWARD COUNTY, FLORIDA; AUTHORIZING PAYMENT FROM THE APPROPRIATE BUDGET CODE NUMBER IN AN AMOUNT NOT TO EXCEED \$91,175.60; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY INTERIM CITY MANAGER KENNIE HOBBS, JR.).

WHEREAS, pursuant to Section 2-144 of the City's Code, the City of Lauderhill ("City") may waive its on competitive bidding and join in on cooperative purchasing plans when in the best interest of the City; and

WHEREAS, the Broward County Sheriff's Office, issued RLI #23004AP for Emergency Equipment for Vehicles and awarded a contract to Shyft Group Upfit Services, Inc., d/b/a Strobes-R-Us ("Contractor"); and

WHEREAS, the City, pursuant to section 2-144 of the City's Code, wishes to piggyback from the Broward County Sheriff's Office's solicitation and enter into an agreement with the Contractor for the purchase of emergency equipment for six police vehicles in an amount not to exceed \$91,175.60.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, THAT:

<u>SECTION 1.</u> The above recitations are true and correct.

<u>SECTION 2.</u> The City is authorized to enter into an agreement with Contractor for the purchase of emergency equipment for six police vehicles in an amount not to exceed \$91,175.60.

<u>SECTION 3.</u> Payment shall be made from the appropriate budget code number.

<u>SECTION 4.</u> This Resolution shall take effect immediately upon its passage.
