A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL APPROVING THE FIRST AMENDMENT TO THE AGREEMENT FOR LEGAL SERVICES BETWEEN THE CITY OF LAUDERHILL AND OTTINOT LAW, P.A., AND APPOINTING OTTINOT LAW, P.A., AS PERMANENT CITY ATTORNEY, SAID AMENDMENT IS ATTACHED AS EXHIBIT "A"; PROVIDING THE MAYOR WITH THE AUTHORITY TO EXECUTE THE FIRST AMENDMENT; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY MAYOR DENISE D. WHERAS, the City Commission has determined that it is in the best interest of the City to appoint Ottinot Law, P.A., as the permanent City Attorney for the City of Lauderhill and it wishes to amend the Agreement for Legal Services with Ottinot Law, P.A.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, AS FOLLOWS:

<u>SECTION 1.</u> That the City Commission hereby approves the First Amendment to the Agreement for Legal Services between the City of Lauderhill and Ottinot Law, P.A., and hereby appoints Ottinot Law, P.A. to serve as permanent City Attorney for the City of Lauderhill in accordance with the First Amendment to the Agreement for Legal Services, attached as Exhibit "A".

<u>SECTION 2.</u> That the City Commission authorizes the Mayor to execute the First Amendment to the Agreement for Legal Services between the City of Lauderhill and Ottinot Law, P.A.

<u>SECTION 3.</u> This Resolution shall take effect immediately upon its passage.
