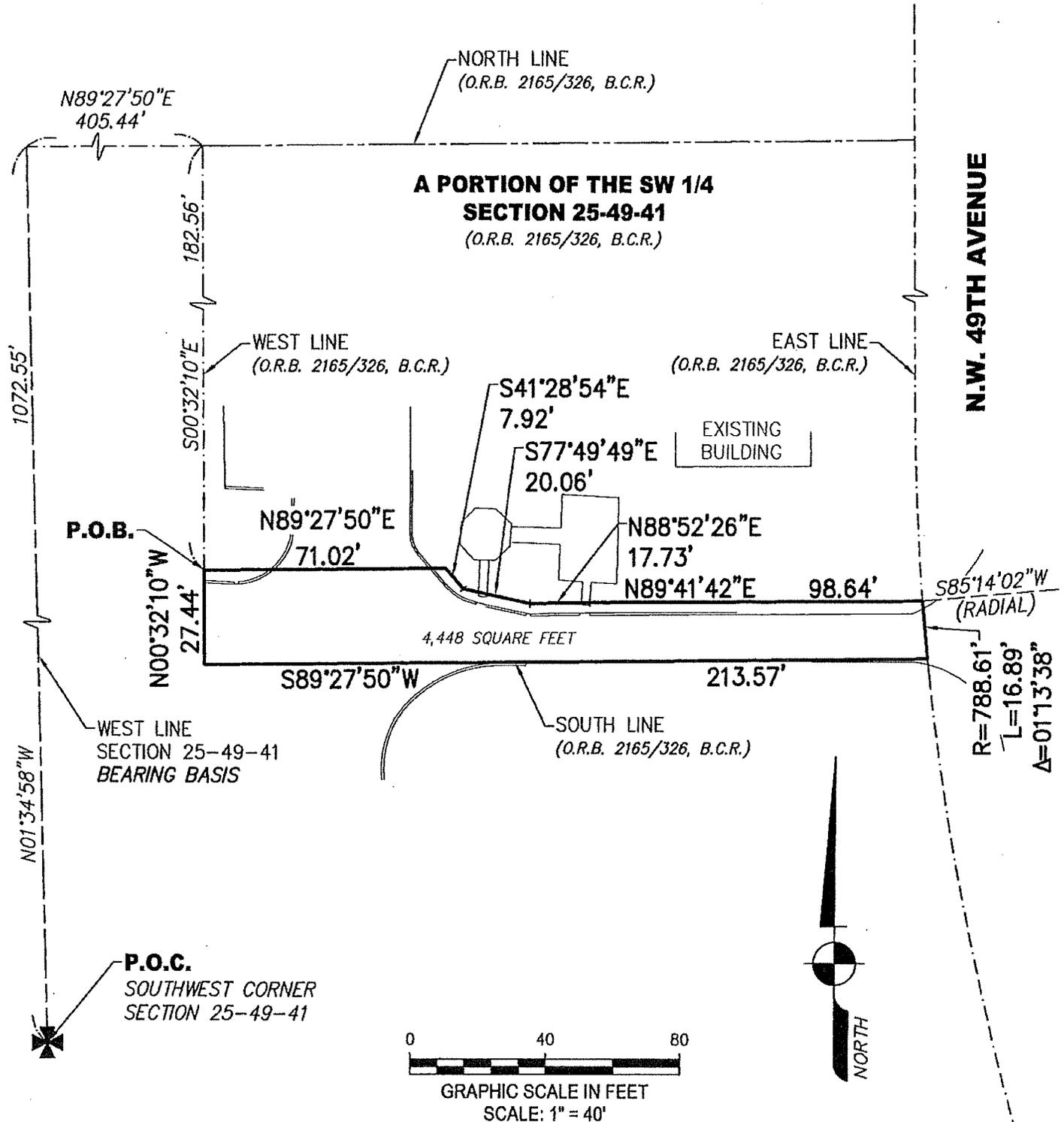

**LAND DESCRIPTION:**

A portion of the SW 1/4 of Section 25, Township 49 South, Range 41 East being a portion of a deed as recorded in Official Records Book 2165, Page 326 of the Public Records of Broward County, Florida; being described as follows:

Commence at the southwest corner of Section 25, Township 49 South, Range 41 East; thence N01°34'58"W along the west line of Section 25, a distance of 1,072.55 feet; thence N89°27'50"E, 405.44 feet to the west line of said deed per Official Records Book 2165, Page 326; thence S00°32'10"E along the west line of said deed per Official Records Book 2165, Page 326, a distance of 182.56 feet to the Point Of Beginning; thence S89°27'50"E, 71.02 feet; thence S41°28'54"E, 7.92 feet; thence S77°49'49"E, 20.06 feet; thence N88°52'26"E, 17.73 feet; thence N89°41'42"E, 98.64 feet to the east line of said deed per Official Records Book 2165, Page 326, also being a point on the arc of a curve, (radial bearing to said point bears S85°14'02"W) concave to the northeast, having a radius of 788.61 feet and a central angle of 01°13'38"; thence southerly along the arc of said curve a distance of 16.89 feet to the south line of said deed per Official Records Book 2165, Page 326; thence S89°27'50"W along the south line of said deed per Official Records Book 2165, Page 326, a distance of 213.57 feet to the west line of said deed per Official Records Book 2165, Page 326; thence N00°32'10"W along the west line of said deed per Official Records Book 2165, Page 326, a distance of 27.44 feet to the Point Of Beginning.

Said lands lying in the City of Lauderhill, Broward County, Florida and containing 4,448 square feet.

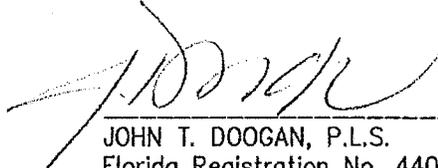
