Minutes 4/15/25 Meeting

A motion to approve the 4/15/25 minutes was made by Chair Liz Turner.

The motion passed 4-0.

The next item on the agenda is a discussion regarding Current Budgets & Projects for Consideration. Yolan Todd (Finance Dept) advises the following balances in each account: Common/Master SND= approximately \$5900, Condo 1= approximately \$192,000 & Condo 11= approximately \$110,000. Karen Fisher representing Building 11 has a quote from vendor Eagle Painting to provide Exterior Painting Services for Building 11's Cooling Tower. The estimate includes supplies & labor for \$5493.05. She explains that it is one of the items that was noted on their 40/50 year Building Report that needs to be addressed. Building Official Randy Youse

explains that he needs an updated report for the Manors Buildings including Building 11; he advises that he needs a report & timeline for the work to be completed on each building from the Engineer(s) (if more than one) on Record (EOR) in the Community. Randy advises that he has a file for each Building in the Manors like every other Community in the City of Lauderdale. Once he receives the report & timeline for each building, a 6-month extension can be applied for if needed. The SND & HOA Reps advise that all their Buildings have renovation work that needs to be completed in order to come into compliance. If Condo 11 decides to move forward with the Cooling Tower Renovation through the SND, Finance/Purchasing will need a detailed Scope of Work regarding the item from their EOR so the item can go to bid. Condo 11's Reps will report back with an update once available.

Chair Liz Turner mentions that there are (6) efficiency units that belong to the Manors Club- their A/Cs are in need of replacement. She inquires if the cost for the replacements could be paid from SND funds. Liz advises that all Manors residents have access to these efficiency units; access is included in their residents' HOA dues. City Staff will check with Attorney Coward & report back to the SND Board.

Building Official Randy Youse further emphasizes the need for the Community to work on their 40/50 year Building Renovation Files; he reminds everyone to start this process by providing the EOR's reports & timelines to his office. With that, Chair Liz Turner makes a motion for the Manors SND's FY 2026 Assessments to be \$100 + 0 mils= Master Association, \$400 + 0 mils= Condo 11 Association & \$400 + 0 mils= Condo 1 Association; Shelly Buchanan seconds this motion.
