

RESOLUTION NO. 20R-01-05

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL WAIVING THE COMPETITIVE BIDDING REQUIREMENTS; APPROVING THE SOLE SOURCE DESIGNATION OF TARGET SOLUTIONS AND CREW SENSE AS THE SOLE DEVELOPER, MANUFACTURER AND/OR PROVIDER OF A COMPREHENSIVE SUITE OF PROPRIETY WEB-BASED SOLUTIONS FOR FIRE AND EMS/FIRE DEPARTMENTS SCHEDULING INCLUDING TRAINING AND ACCESS FOR CONTINUING EDUCATION TO EARN CERTIFICATIONS; AUTHORIZING THE PURCHASE IN AN AMOUNT NOT TO EXCEED \$84,000.00 FROM BUDGET CODE NUMBER 190-611-04910; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, CHARLES FARANDA)

WHEREAS, Target Solutions and Crew Sense has represented that they are the sole developer, manufacturer, and/or provider of certain proprietary web-based solutions for the Fire and EMS/Fire Departments scheduling, which includes training and limited access for continuing education to earn certifications; and

WHEREAS, Section 2-141 of the City of Lauderhill Code of Ordinances, designates situations where competitive bidding is not required; and

WHEREAS, Section 2-141(c) provides that non-competitive supplies such as products that are available only from a sole source, such as unique, custom, patented or franchise supplies or services are exempt from the competitive bidding requirements; and

WHEREAS, this Resolution approves the sole source designation of Target Solutions and Crew Sense and waives the competitive bidding requirements;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

SECTION 1. That the competitive bidding requirements are hereby waived, as this purchase is exempt from the competitive bidding requirements pursuant to Section 2-141(c) of the City Code since Target Solutions and Crew Sense is hereby designated as the sole source developer, manufacturer and/or provider of certain proprietary web-based solutions for the Fire and EMS/Fire Departments scheduling, which includes training and limited access for continuing education to earn certifications.

SECTION 2. Payment in an amount not to exceed \$84,000.00 from Budget Code Number 190-611-04910, is hereby approved.

SECTION 3. This Resolution shall take effect immediately upon its passage.
