**A RESOLUTION OF THE LAUDERHILL COMMUNITY REDEVELOPMENT AGENCY APPROVING THE FISCAL YEAR 2024 BUDGET FOR THE CENTRAL COMMUNITY REDEVELOPMENT AGENCY IN THE TOTAL AMOUNT OF \$115,500.00 APPROVING THE FISCAL YEAR 2025 BUDGET FOR THE EASTERN COMMUNITY REDEVELOPMENT AGENCY IN THE TOTAL AMOUNT OF \$1,609,249.00; PROVIDING THAT BOTH OF THESE BUDGETS WILL BE INCORPORATED INTO THE CITY OF LAUDERHILL GENERAL OPERATING BUDGET FOR FISCAL YEAR 2025; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY EXECUTIVE DIRECTOR, SEAN HENDERSON).**

BE IT RESOLVED BY THE CITY OF LAUDERHILL COMMUNITY REDEVELOPMENT AGENCY, THAT:

SECTION 1. The Tentative Fiscal Year 2025 Budget for the Lauderhill Central Community Redevelopment Agency (CRA) in the total amount of \$115,500.00 which shall be incorporated into the City of Lauderhill Budget, a copy of which is attached hereto and incorporated by reference, is hereby approved.

SECTION 2. The Tentative Fiscal Year 2025 Budget for the Lauderhill Eastern Community Redevelopment Agency (CRA) in the total amount of \$1,609,249.00 which shall be incorporated into the City of Lauderhill Budget, a copy of which is attached hereto and incorporated by reference, is hereby approved.

SECTION 3. That both of the Lauderhill CRA Budgets will be incorporated within the City of Lauderhill general budget.

SECTION 4. This Resolution shall become effective immediately upon its passage and adoption.
