ACTION IS NEEDED TO ACCEPT THE BID PROPOSAL AND TO AWARD BID 2025-048 TO "C & W PIPELINE INC." TO CONSTRUCT THE DRAINAGE IMPROVEMENTS IN ACCORDANCE TO CONSTRUCTION PLANS PREPARED FOR THE PROJECT AND TO ENHANCE THE EXISTING STORMWATER MANAGEMENT SYSTEMS WITHIN THE MAPLE RUN COMMUNITY. THE PROPOSED IMPROVEMENTS INCLUDE: (1) INSTALL NEW INTERCONNECT PIPE(S) SYSTEM BETWEEN THE NORTH AND SOUTH LAKES, (2) INSTALL NEW CONTROL STRUCTURE, (3) EXTEND THE EXISTING 24" BACKBONE CONVEYANCE SYSTEM ALONG NW 33 STREET, (4) ADD CONCRETE HEADWALLS AT 4 OUTFALL PIPES, (5) RECONFIGURE 8" DEEP ROADSIDE SWALES, (6) ADD A NEW CATCH BASIN ALONG NW 34 STREET, AND (7) INSTALL EXFILTRATION SYSTEMS IN THE EXISTING PARKING LOTS ACCESSED BY NW 33 ST.
