Cost Summary/ Fiscal Impact:

Kennie Hobbs and Andrea M. Anderson's terms will expire November 2025 and both current trustees have expressed interest in continuing to serve on the board; both seats are appointed by the Commission as a whole. Major David Hennessy was elected by the Lauderhill Police Officers as their representative. All terms are for four (4) years, to expire November 2029.
