CLASS DESCRIPTION, 2020**

POSITION TITLE: OPERATIONS LEAD (LPAC)

GENERAL DESCRIPTION OF DUTIES

Under the supervision of the Operations Manager, the purpose of the position is to provide oversight during the hours that the facility is open to the public, to provide direction to Operations I/Operations II and independently contracted housekeeping/security/parking staff, and to complete operations and logistics related to any event taking place at the LPAC. Position is responsible for ensuring a well-balanced event operationally, enforcing all safety policies and procedures throughout the venue. Performs related work as required.

SPECIFIC DUTIES AND RESPONSIBILITIES

EXAMPLES OF ESSENTIAL FUNCTIONS

Assists Department in areas including, but not limited to, customer relations, guest wayfinding, enforcement of all show related policies and procedures, providing show specific information to all other Front of House positions, independent contractor oversight, hands on housekeeping, and overall building security.

Acts on behalf of the department to provide professional, customer-focused, welcoming service, including activities such as greeting patrons/clients, directing patrons throughout the facility, and resolving a variety of theatre related issues – including double seating, rules regarding photography/cell phones, safety procedures, etc.

Delegates tasks to Operations I/Operations II/independent contractors, and acts as the manager on duty during hours when the facility is open and the Operations Manager is absent.

Communicates with the Operations Manager, Box Office Manager and House Manager effectively and frequently during events.

Promotes upcoming events and shares information with patrons.

Resolves patron disputes and re-seats parties as necessary to maintain a peaceful environment in the Lobby and House, striving to reach an equitable arrangement while upholding established policies.

Conducts a walkthrough of the House before the show to ensure that the facility is safe, in good repair and fully stocked with supplies in all public areas.

Trains all new independent contractors and Operations I/Operations II on their first few shifts by allowing them to shadow at all possible opportunities.

Serves as a liaison to renters/event coordinators, which includes gauging their satisfaction and enforcing all house rules which are relevant to their event.

Assists with special event set-up and break-down as needed.

Assist the Operations Manager with special projects including painting, sign installation, hurricane preparedness, etc.

May perform courier functions as needed.

The list of essential functions, as outlined herein, is intended to be representative of the tasks performed within this classification. It is not necessarily descriptive of any one position in the class.

OPERATIONS LEAD (LPAC)

The omission of an essential function does not preclude management from assigning duties not listed herein if such functions are a logical assignment to the position.

MARGINAL FUNCTIONS

While the following tasks are necessary for the work of the unit, they are not an essential part of the purpose of this position and may also be performed by other unit members.

Performs related duties as directed.

MINIMUM TRAINING AND EXPERIENCE

High school diploma or GED; supplemented by minimum six (6) months Theatre I, Theatre II, Theatre III Operations I, Operations II or customer service and live performance experience; or an equivalent combination of education, training, and experience.

SPECIAL REQUIREMENTS

Valid Florida State Driver's License.

PERFORMANCE APTITUDES

Data Utilization: Requires the ability to review, classify, categorize, prioritize, and/or analyze data and/or information. Includes exercising discretion in determining data classification, and in referencing such analysis to established standards for the purpose of recognizing actual or probable interactive effects and relationships.

Human Interaction: Requires the ability to exchange information for the purpose of obtaining information or clarifying details. Performs such within well-established policies, procedures and standards.

Equipment, Machinery, Tools, and Materials Utilization: Requires the ability to start, stop, operate, and monitor the functioning of equipment, machinery, tools, and/or materials used in performing essential functions.

Verbal Aptitude: Requires the ability to utilize a wide variety of reference and descriptive data and information.

Mathematical Aptitude: Requires the ability to perform addition, subtraction, multiplication and division.

Functional Reasoning: Requires ability to apply principles of rational systems. Ability to interpret instructions furnished in written, oral, diagrammatic or schedule form. Ability to exercise independent judgement to adopt or modify methods and standards to meet variations in assigned objectives.

Situational Reasoning: Requires the ability to exercise the judgment, decisiveness and creativity in situations involving a variety of generally pre-defined duties, which are often characterized by frequent change.

ADA COMPLIANCE

Physical Ability: Tasks involve the ability to exert light physical effort in sedentary to light work, but which may involve some lifting, carrying, pushing and/or pulling of objects and materials of medium weight (5-30 pounds). Tasks may involve extended periods of standing.

Sensory Requirements: Some tasks require visual perception and discrimination. Some tasks require oral communications ability.

OPERATIONS LEAD (LPAC)

Environmental Factors: Tasks are regularly performed without exposure to adverse environmental conditions, such as dirt, dust, pollen, odors, wetness, humidity, rain, fumes, temperature and noise extremes, machinery, vibrations, electric currents, traffic hazards, animals/wildlife, toxic/poisonous agents, violence, disease, or pathogenic substances.
