## **Request Action:**

Pass an Ordinance to Amend the City Charter, Section 8.03 to amend the provisions regarding acting city attorney as approved at the November 6, 2018 general election.

#### Need:

To amend the City Charter consistent with the approved Charter amendments.

## Summary Explanation/ Background:

Four (4) Charter Amendments were proposed on the general election ballot of November 6, 2018. All 4 ballot amendments passed. This Ordinance codifies the amendment to Charter Section 8.03 designating that the Assistant City Attorney is the Acting City Attorney in his/her absence.
