RESOLUTION NO. 24R-08-161: A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL APPOINTING VARIOUS MEMBERS OF THE LAUDERHILL COMMUNITY AND BUDGET ADVISORY BOARD BY THE CITY COMMISSION AS A WHOLE FOR POSITIONS THAT HAVE EXPIRED FOR THE TERMS PROVIDED; PROVIDING FOR AN EFFECTIVE DATE.

Request Action:

Adopt a Resolution appointing individuals to fill expired positions for each zone as members of the Lauderhill Community and Budget Advisory Board for a two (2) year term, expiring July 2026 for Seats 1, 5, 7, 8, and 9, and for a one (1) year term for alternate positions expiring July 2025 (Seats 10 and 11).

Need:

To fill expired terms on the Lauderhill Community and Budget Advisory Board.

Summary Explanation/ Background:

Applicants are listed below with their zone of residence noted. Most recently appointed board members are also noted as such.

The Board includes 1 seat per geographic area (7 total), 2 seats for a member at large (2 total), and 2 seats for alternate members (2 total). Members at large and alternate members may reside in any geographic area.

<u>Geographic Zone/Seat 5</u> (2 year appointment, to expire July 31, 2026) Marci Bennett - Current Board Member for Seat 5 (Resident of Zone 5) Eric Walton (Resident of Zone 5 - May be considered for appointment to Seat 5 or any "At Large" Seat [ex. Seat 8, Seat 9, Seat 10, or Seat 11])

<u>Geographic Zone/Seat 7</u> (2 year appointment, to expire July 31, 2026) Sam Wilkerson - Current Board Member for Seat 7 (Resident of Zone 7)

<u>Seat 9 - At Large</u> (2 year appointment, to expire July 31, 2026) Melvin Parrish - Current Board Member for Seat 9 (Resident of Zone 3)

<u>Seat 10 - Alternate One</u> (1 year appointment, to expire July 31, 2025) Willie Mae Cooper - Current Alternate Board Member (Resident of Zone 6)

<u>Seat 11 - Alternate Two</u> (1 year appointment, to expire July 31, 2025) Felicity Swanson - Current Alternate Board Member (Resident of Zone 7)
