A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL WAIVING COMPETITIVE BIDDING REQUIREMENTS TO AUTHORIZE AN AGREEMENT WITH HYDROMAX USA, LLC AND WSD CONTRACTING FOR FIRE HYDRANT MAINTENANCE, REPAIR AND REPLACEMENT SERVICES BASED ON A PIGGYBACK FROM BROWARD COUNTY'S CONTRACT NO. BLD2128387B1; AUTHORIZING PAYMENT IN AN AMOUNT NOT TO EXCEED \$200,000.00 FROM THE APPROPRIATE BUDGET CODE NUMBER; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY INTERIM CITY MANAGER KENNIE HOBBS).

WHEREAS, pursuant to Section 2-144 of the City's Code, the City of Lauderhill ("City") may waive its competitive bidding process and join in on cooperative purchasing plans when in the best interest of the City; and

WHEREAS, Broward County, Florida, has already solicited bids and awarded a contract to Hydromax USA and WSD Contracting for fire hydrant maintenance, repair and replacement services; and

WHEREAS, the City of Lauderhill wishes to enter into an agreement with Hydromax USA and WSD Contracting based upon Broward County's Contract No. BLD2128387B1, for fire hydrant maintenance and replacement services; and

WHEREAS, the City Commission has determined that entering into an agreement as set forth herein would serve the best interests of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, THAT:

<u>SECTION 1.</u> The waiver of competitive bidding as set forth in section 2-144 of the City's Code, is hereby approved.

SECTION 2. The City is authorized to enter into an agreement with Hydromax USA and WSD Contracting utilizing the Broward County piggyback contract, in an amount not to exceed \$200,000.00, for fire hydrant maintenance, repair and replacement services.

SECTION 3. Payment shall be made	from the appropriate b	oudget code number.
