Request Action:

We respectfully request approval to piggyback on Florida Sheriff's Association (FSA) Contract No. FSA25-VEF19.0. Item 214 awarded to Matheny Fire & Emergency, for Fire & Rescue Vehicles, Boats, and Equipment. Utilizing this contract will allow the City of Lauderhill to efficiently and cost-effectively obtain the necessary fire vehicles while ensuring compliance with procurement regulations.

Need Summary Explanation/ Background:

The purpose of this is to purchase a new fire-rescue truck chassis with intentions of remounting our support truck (which is currently on a 1997 chassis) in accordance with the FSA base specification.
