THE CITY COMMISSION IS BEING REQUESTED TO APPROVE THE SOLE SOURCE DESIGNATION TO FARO TECHNOLOGIES.

**Need:**

FARO TECHNOLOGIES IS THE SOLE DEVELOPER AND MANUFACTURER OF THE FARO FOCUS LASER SCANNERS AND EQUIPMENT. FARO IS ALSO THE SOLE PROVIDER OF HARDWARE AND SOFTWARE SERVICE, WARRANTY, MAINTENANCE, ANNUAL CALIBRATION, AND TRAINING PROGRAMS ASSOCIATED WITH FARO TECHNOLOGIES.

**Summary Explanation/ Background:**

WITH A WIDE VARIETY OF FEATURES, INCLUDING RANGE, IMAGE QUALITY, AND CAPTURE SPEED, THE FOCUS LASER SCANNER SIGNIFICANTLY REDUCE THE TIME AND INCREASE THE EFFECTIVENESS OF DOCUMENTING, MEASURING, AND ANALYZING FORENSIC SCENES/CRIME SCENE MAPPING TECHNOLOGY.
