

RESOLUTION NO. 19R-01-20

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL WAIVING COMPETITIVE BIDDING REQUIREMENTS; AUTHORIZING THE PURCHASE OF A VAC-CON SEWER COMBINATION CLEANER FROM SOUTHERN SEWER EQUIPMENT SALES AND LOU BACHRODT BASED UPON THE PIGGY BACK OF THE FLORIDA SHERIFF`S ASSOCIATION CONTRACT (#FSA18-VEH160); PROVIDING FOR PAYMENT IN THE AMOUNT OF \$417,807.14 FROM BUDGET CODE NUMBER 401-917-06440; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, CHARLES FARANDA)

WHEREAS, Section 2-144 of the Code provides that the City of Lauderhill may join in on cooperative purchasing plans without bids when the best interests of the City would be served; and

WHEREAS, the Florida Sheriff`s Association has already solicited bids and awarded a contract (#FSA18-VEH160) to Southern Sewer Equipment Sales and Lou Bachrodt for the purchase of a Vac-Con Sewer Combination Cleaner; and

WHEREAS, the City of Lauderhill wishes to award the contract to Southern Sewer Equipment Sales and Lou Bachrodt based upon the bids by the Florida Sheriff`s Association to purchase a Vac-Con Sewer Combination Cleaner, as indicated in the attached; and

WHEREAS, the City Commission has determined that the award of this contract as set forth herein would serve the best interests of the City;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

Section 1. The waiver of competitive bidding is hereby approved.

Section 2. The award of the contract to Southern Sewer Equipment Sales and Lou Bachrodt for the purchase of a Vac-Con Sewer Combination Cleaner, based upon the bids solicited by the Florida Sheriff`s Association(#FSA18-VEH160), a copy of which is attached hereto and incorporated by reference, is hereby approved.

Section 3. Providing that payment in an amount not to exceed \$417,807.14 shall be made from Budget Code Number 401-917-06440.

Section 4. This Resolution shall take effect immediately upon its passage.
