

On October 10, 2017, the Broward County Commission "County" and Keylite Power & Lighting Corp. "Keylite", entered into a System and Service Agreement "R1426611P1" Fire Station Alerting "FSA". The system and service agreement provides goods and services for the FSA system to support current and future fire department alerting needs for Broward County and local public safety personnel. The agreement allows for municipalities in Broward County to piggy-back for goods and services.

The initial term of the Agreement commenced on October 10, 2017, and ends five (5) years after the date of Final Acceptance. Final Acceptance was achieved on June 30, 2020. The parties agree the initial term ends on June 30, 2025. The agreement also allows for two (5) additional five (5) renewal terms.

In addition, Keylite is the sole integrator and service provider for the Fire Station Alerting Network "FireNet". The FireNet Network provides wireless connectivity with redundancy of all regional participants' fire stations to the County E-9-1-1 Regional Dispatch Centers. The FSA includes the utilization and integration of the US Digital Design Phoenix G2 Fire Station Alerting System used to alert municipals stations via the County's Computer-Aided-Dispatch (CAD) system.

Currently, the City of Lauderdale is a participant of the Broward County E-9-1-1 Regional Dispatch and has utilized Keylite for the acquisition, installation, integration of the FSA system and support.
