

**RESOLUTION NO. 26R-01-18**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, APPROVING AND AUTHORIZING THE EXECUTION OF A MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF LAUDERHILL AND THE COMMUNITY FOUNDATION OF BROWARD FOR THE ADMINISTRATIVE CLOSEOUT OF A GRANT AGREEMENT RELATED TO THE LAUDERHILL HEALTH AND PROSPERITY PARTNERSHIP; AUTHORIZING THE CITY MANAGER TO EXECUTE THE MEMORANDUM OF UNDERSTANDING AND ALL RELATED DOCUMENTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE. (REQUESTED BY CITY MANAGER, KENNIE HOBBS, JR.).**

WHEREAS, the Community Foundation of Broward ("CFB") is a Florida nonprofit organization that administers grant funding in support of community impact initiatives; and

WHEREAS, by Resolution No. 23R-08-197, the City Commission approved a Grant Agreement with CFB for an award of Three Hundred Fifty Thousand Dollars (\$350,000.00) to build capacity for the Lauderhill Health and Prosperity Partnership ("LHPP") initiative; and

WHEREAS, by Resolution No. 25R-09-166, the City Commission rescinded Resolution No. 21-03-59 and eliminated LHPP as an initiative of the City; and

WHEREAS, the original Grant Agreement term concluded in June 2025, and subsequent to that conclusion the City requested an extension of certain grant-funded activities, which request was not approved by CFB due to the elimination of LHPP as a City initiative; and

WHEREAS, the City and CFB desire to enter into a Memorandum of Understanding ("MOU") to establish a cooperative, non-binding framework for the orderly and timely administrative closeout of the Grant Agreement, including the submission of final reports and the return of any unexpended grant funds; and

WHEREAS, the City Commission finds that approval of the MOU serves a valid public purpose and is in the best interest of the City and its residents by ensuring transparency, accountability, and proper fiscal closeout of grant funds.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, THAT:

Section 1. The City Commission hereby approves the Memorandum of Understanding between the City of Lauderhill and the Community Foundation of Broward for the administrative closeout of the Grant Agreement.

Section 2. The City Manager is hereby authorized to execute the Memorandum of Understanding and any related documents necessary to carry out the intent of this Resolution, subject to approval as to legal form by the City Attorney.

Section 3. This Resolution shall take effect immediately upon its passage and approval.
