A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, APPROVING AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SPONSORSHIP AGREEMENT BETWEEN THE CITY OF LAUDERHILL AND BROWARD COUNTY FOR A CULTURAL EVENT KNOWN AS LAUDERHILL'S 6TH ANNUAL BEERB-Q ON 38TH AVENUE FESTIVAL; ACCEPTING COUNTY SPONSORSHIP FUNDING IN THE AMOUNT OF FIFTY THOUSAND DOLLARS (\$50,000) AND APPROVING A REQUIRED CITY CASH MATCH OF FIFTY THOUSAND DOLLARS (\$50,000); PROVIDING FOR TERMS AND CONDITIONS; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, KENNIE HOBBS, JR.).

WHEREAS, the City of Lauderhill (the "City") periodically partners with Broward County (the "County") to support cultural, artistic, and community programming within the City; and

WHEREAS, Broward County, through its Cultural Division, has awarded the City sponsorship funding in the amount of Fifty Thousand Dollars (\$50,000) in support of a City-hosted cultural event known as City's 6th Annual Beer-B-Q on 38th Avenue Festival; and

WHEREAS, the Sponsorship Agreement requires the City to provide a dollar-for-dollar cash match in the amount of Fifty Thousand Dollars (\$50,000) to be used for eligible event-related expenses; and

WHEREAS, the City recognizes that participation in the County's Cultural Sponsorship Program serves a valid public purpose by promoting community engagement, cultural enrichment, and economic activity consistent with the City's goals and policies; and

WHEREAS, the City Commission finds that entering into the Sponsorship Agreement is in the best interest of the residents and aligns with applicable laws and regulations governing intergovernmental cooperation and public purpose expenditures.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, THAT:

- Section 1. The foregoing recitals are hereby adopted and confirmed as true and correct and incorporated herein by this reference.
- Section 2. The City Commission of the City of Lauderhill hereby approves the Sponsorship Agreement between the City and Broward County and authorizes the City Manager to execute the Agreement and take all necessary action to implement its terms.
- Section 3. The City Manager is authorized to allocate and expend the required City cash match of Fifty Thousand Dollars (\$50,000) from duly appropriated funds consistent with the approved Fiscal Year budget.

Section 4. This Resolution shall take effect immediately upon its passage and approval.
